REGULAR SESSION/CALL TO ORDER/ATTENDANCE - Vice-Chair Kevin Richards called the meeting to order followed by the Pledge of Allegiance.

AGENDA ADOPTION – Courtney Snead motioned to approve the agenda as presented – **Approved 4/0.**

PRESENTATIONS/REPORTS/COMMUNICATION/DISCUSSION ITEMS

Superintendent Ken Parshall reminded the board of the virtual Central Oregon K-12 Legislative Forum to take place on December 17th at 4:30pm-6:00pm.

Superintendent Ken Parshall and Director of Student Services Kira Fee gave the board the reopening update that included information about the following: health metrics; no limited inperson instruction (LIPI) due to staff absences and athletics—OSAA moved back athletics until February 2nd.

Conversation took place regarding the limited in-person instruction (LIPI) and the Governor's recent information. Board members discussed the potential of a letter to the State from our board of directors requesting to give families a choice in the matter. Superintendent Parshall said he would support the board and their efforts to write a letter to Governor Brown.

In order to confirm the board agreement, Courtney Snead motioned to send a letter from the JCSD Board of Directors stating their stance in local decision making process requesting that parents are provided a choice; motion passed – **Approved 4/0.**

Board Vice-Chair Kevin Richards confirmed that Courtney Snead will DRAFT the letter to Governor Kate Brown.

Conversation continued about the logistics of getting kids back in school, transportation concerns, the expense and capacity on reserves.

Public comment was given by: Joan McDonald; Alexa Gassner; Jen Flowers and Karla Simmelink. They shared their concerns about getting students back in school; the quality of the education (in-person, remote and returning to school); concerns about the mental health of students and the importance of athletics.

Board Vice-Chair Kevin Richards thanked the citizens for speaking this evening and said the board takes their comments very seriously and as parents the board faces some of those same challenges and frustrations.

Communication continued regarding the comments and concerns shared by the citizens; the need to reach out to elected officials; the differences between our district and Culver and the fact that during this difficult time (COVID pandemic) it is a balancing act with the ever changing communication.
