MEMORANDUM OF AGREEMENT Extended Responsibility Positions Schedule 2023-24 Changes

Representatives of the Jefferson County School District 509-J ("District") and the Madras Education Association ("Association") hereby recognize the need to update the Extended Responsibility Positions Schedule for the 2023-24 school year in order to remain competitive for coaching salaries and more accurately reflect current needed positions and eliminate unused positions in the District.

To that end, the following changes will be made beginning with the 2023-24 school year as reflected in attached Exhibit A:

- Move MHS Head Baseball Coach, Head Softball Coach, and Head Track Coach from "B" to "A".
- Move MHS Assistant Baseball Coach, Assistant Softball Coach and Assistant Track Coach from "C" to "B".
- Add MHS Assistant Soccer Coach to "B".
- Add MHS Assistant Tennis Coach, Head Swim Coach, Event Organizer, and Concessions to "C".
- Add MHS Assistant Swim Coach and Assistant Cheer Coach to "D".
- Add MHS Native Business Leadership Club and Skills USA to "E".
- Remove MHS School Curriculum Leaders from "F".
- Remove MHS Vocational Fair Coordinator and add National Honors Society and Art Club and Graphic Arts Club to "F".
- Update MHS "Student Council Advisor" to "Student Leadership Advisor".
- Remove Middle School Vocal Music, Newspaper, Girls Fitness Club Advisor, Vocational Fair Coordinator, and Project Reach Coordinator.
- Add Middle School Web Coordinator to "E".
- Add Middle School National Honors Society to "F".
- Remove words "DISTRICT-WIDE" from "F" row.
- Eliminate Elementary column.

To the extent this MoA departs from the normal policy, contractual, or statutory provisions, it is intended to act as a non-precedent setting, one-time only arrangement binding on the Association and the District only for the duration of this MoA. This MoA will void the MoA titled the same and signed on May 16, 2023.
